

Saint Mary Catholic Community School: 2021 – 2022 Tuition Schedules

A student's tuition helps pay for instructional costs. Partial operational costs and co-curricular opportunities are funded by Home & School Association fund-raising efforts. It is for this reason that the parents (or legal guardian) in each school family are required to fulfill the following 2 commitments to the Home & School Association:

1) Service Hour Commitment: Each family with a student in grades K-8 is to complete no fewer than twelve hours of service towards Home & School fundraising efforts. Each family's fundraising hours will be audited on April 1, 2022. Any K-8 family with incomplete fundraising hours will incur an additional assessment of \$50 for each incomplete hour – to a maximum of \$600. This additional assessment will be added to the tuition account in April 2022.

2) TRIP Contribution Commitment: Each family with a student in grades K-8 is required to generate \$200 in TRIP profits. Each family's TRIP account will be audited on April 1, 2022. Any K-8 family with incomplete TRIP profits will be charged the difference to their tuition account. This additional assessment will be added to the tuition account in April 2022. **Note:** 100% of the first \$200 in TRIP profits will go to the Home & School Association. 75% of profits after the \$200 requirement is met will go to the family's tuition account.

The tuition schedule for **JR PRE-K – 2 DAY** (3 year-olds) \$ 1,584 per child
Tuesday & Thursday - AM or PM

The tuition schedule for **JR PRE-K – 3 DAY** (3 year-olds) \$ 2,080 per child
Monday, Wednesday, Friday - AM or PM

The tuition schedule for **PRE-K – 5 DAY** (4 year-olds) \$ 2,547 per child
AM or PM option

The tuition schedule for **ROMAN CATHOLIC STUDENTS GRADES K-8** \$ 4,863 per child

The tuition schedule for **NON-CATHOLIC STUDENTS GRADES K-8** \$ 5,549 per child

Roman Catholic families may apply for a tuition subsidy from their home parish. Each parish determines subsidy eligibility requirements. The maximum subsidy amounts for students in Grades K – 8:

1 child	\$ 702	3 children	\$5,741
2 children	\$2,744	4 children	\$9,035

ADDITIONAL FEES/DEPOSIT

RETURNING FAMILY REGISTRATION FEE: \$50.00 per family. This fee is due at the time of registration. Registration fee is non-refundable and non-applicable to tuition, bookbill and/or other fees.

NEW FAMILY APPLICATION FEE(S): \$50.00 for first student; \$25 each additional student. This fee is due at the time of application. Application fee(s) are non-refundable and non-applicable to tuition, bookbill and/or other fees.

NEW FAMILY TUITION DEPOSIT: \$300.00 per K-8 family. This tuition deposit is due at time of Enrollment. It is non-refundable and will be applied to the August tuition payment
OR
\$100.00 per Nursery/Pre-K family. This tuition deposit is due at time of Enrollment. It is non-refundable and will be applied to the August tuition payment.

DEVICE FEE: \$340.00 per child in Grades K – 8. Chromebooks for new students, and all replacements for current students, must be purchased through the school effective the 2021-2022 school year due to the required Chrome Management license that must be installed.

All parents/adults who volunteer (in classroom, on field trips & HSA fundraisers) **are required** to complete Virtus Training and a National Criminal Background Check. The fee for the Background check is currently \$15.00 every 5 years.
